FINANCING TEAM ACADEMY 2019

At DUO you can receive a student loan with extremely beneficial terms: you don't pay any interest in 2019, you have a long repayment period (35 years), and after completing your study you never have to pay back more than 4% of your additional total income above minimum wage. STUDY FINANCING

Team Academy (Schoolvision Foundation) is a recognized and accredited education institution, because of this you can request financial support for your study. The available Hbo study financing consists of: a loan, the tuition credit, the student travel product, and potentially an additional Scholarships.

ADDITIONAL SCHOLARSHIP

If your parents can pay little, or none of your tuition fees, you may also qualify for an additional scholarship from DUO. This depends on the combined yearly income of your parents. The number of children they support and amount of student debt they-themselves have is also considered. Calculate how much you qualify for, depending on your situation, with the calculation feature on duo.nl. Please note, this additional financial support is provided in the form of a loan, however, once/if you graduate (within 10 years) the loan converts to a grant and does not have to be paid back.

LOAN & TUITION CREDIT LOAN

As a student at a private educational institution you are allowed to borrow up to €882,47 per month. This amount includes the additional scholarship mentioned (should you qualify). If you don't receive an additional scholarship, then you can loan the remaining amount. The interest rate on the loan differs per calendar year. In 2018 the interest rate is 0%. In 2019 it is also set for 0%. After completion for your study the interest rate will remain fixed for 5 years.

TUITION CREDIT

?

As a post-secondary student you have the right to receive study financing for your study and can request tuition credit at DUO. Tuition credit is a loan meant for the payment of tuition fees up to €10.300,- per year. This is paid per month with your other financial support. The interest rate on the loan differs per calendar year. In 2018 the interest rate is 0%. In 2019 it is also set for 0%. Interest begins to accrue the month you receive your loan. After completion of your study the interest rate will remain fixed for 5 years.

LOAN REPAYMENT

?

You can receive a loan from DUO with extremely beneficial terms. In the new study financing system you have more time to repay your loan: Up to 35 years. The repayment of the rent-accruing loan begins ± years after the end of your study until maximum 35 years later. You never have to pay more than 4% of your income-above-minimum-wage. If you are single and have no dependents, you pay maximum 4% of your income above 100% of minimum-wage. In all other cases you pay maximum 4% of your income above 143% of minimum-wage (note: your partner's income is included in the calculation of your financial capacity).
